The Earnings Verification exchange is designed so employers may specify if the employee was working and performed services, and if the individual was payed tips, commission, bonus, severance, wages in lieu of work, vacation, holiday, or sick pay. Selection of these earnings types is used in subsequent screens to determine the applicable data entry fields that are presented to the employer for data entry. The state sets indicators in each wage request record, which instruct E-Response to optionally display the data entry fields for date paid or date allocated that are associated with each particular earnings information data entry field(s). Below is a screen shot illustrating the case where an employer checks the boxes associated with the earnings they will report for the employee.
